An amount of Rs. 10,000/- will be paid to the pregnant female employees as Nutrition Allowance, one time during their pregnancy. This amount may be claimed by a female employee for a maximum of two instances of pregnancy. The amount will be paid through HRMS in the same way as other medical bills are paid.
