**TWO DAYS' BANKING STRIKE ON 24<sup>th</sup> - 25<sup>th</sup> MARCH 2025 - AIRBEA (NFRBE, NFRBO & NFRRB) TO JOIN THE SAME - NOTICE FOR AGITATIONAL PROGRAMME INCLUDING TWO DAYS' STRIKE**

UFBU has given a call for Two Days' Banking Strike on 24<sup>th</sup> -25<sup>th</sup> March 2025 on the major demands of –

1. Adequate recruitment in all cadres, to regularize all temporary employees,
2. Implementation of 5 day work week in Banking Industry,
3. Immediate withdrawal of the recent DFS directives on PLI, which threaten job security, create division and discrimination amongst employees and officers,
4. Amend Gratuity Act to increase the ceiling to Rs.25 lakh on the lines of Scheme for Government employees along with the exemption from Income Tax.
5. Do not recover Income Tax on staff welfare benefits given to employees and officers on concessional terms, Managements to bear the same.
6. Safety of Bank Officers /Staff against the assault/ abuse by unruly public.

The matter was placed in our 15<sup>th</sup> Conference held on 8 - 9 February, 2025 at Ballari, Karnataka and it was decided that -

As the aforesaid demands are very common in case of RRB sector too we fully endorse the same.

AIRRBEA will join the Strike on 24 - 25 March 2025, with our **Additional demands** as follows -

1. Immediate formation National Rural Bank of India with state level RRBs, totally delinked from existing Sponsor Banks.
2. Immediate revision of Promotion rules, Service rules and Manpower norms to recruit staff in large number of vacant posts all over the country to serve the requirements of the RRBs.
3. Regularisation of all part-time, casual and daily waged staff members as per the Hon'ble Supreme Court Orders followed by APGVB.
4. Full parity of wage structure, Leave Rules, Staff Loans etc - Proper implementation of GOI order dated 08.07.2024 - IBA to be advised to include RRBs for wage revision negotiation.
5. Proper and full implementation of Pension parity / Computer Increment w.e.f 01.11.1993 with proper guidance to RRBs and to fix up accountability on RRB Chairmen for violation of GOI instructions/ directions of the Hon'ble Supreme Court dated 12.08.2024.
6. Proper implementation of Compassionate Appointment Scheme at par with NCBs.

This may kindly be treated as Notice under Section 22 (1) of ID Act, 1947.
