MANDATORY LEARNING EXAMINATION

1. Please ref. to staff circular no.18, 28, 32, 33 & 37 of 2019 on the matter cited above.
2. In the aforesaid context we would like to draw your kind attention on appointment and promotion rules 2013, which speaks as under:-

“Power to interpret: - The power to interpret these Rules shall vest in the Central Government and the Central Government may issue such administrative instructions or guidelines in consultation with the National Bank as may be necessary to give effect to and carry out the provisions of these rules or to remove any difficulty in their implementation”
3. If we will go to staff circular 18 of 2019, in the preamble it is spelt out to cover three major areas, viz:- (1) standardised/ improved common Annual Appraisal Report Format(AARF) for all the RRBs and (2) Mandatory learning.
4. Here, if we will go to point no. (1) & (2) of the preamble of staff circular 18 of 2019 , it has got some direct impact on career progression of staff members. It is advised that those staff members who have already passed the Examinations like CIF, Specified Person, AMFI course for Mutual Fund are not required to appear in the Mandatory Learning Examination, which are not relevant as per RRB Rules. When the standard of examination is different, why 10 marks is already allotted to them those who have qualified the aforesaid examination? **This speaks of the hidden agenda of conducting this mandatory learning examination.**
5. The above circular instructions are a complete violation to GOI directives issued on promotion and appointment of RRB staff. Hence, we request your good office to issue instruction to stop the scheduled examination immediately. **Else, we'll be compelled to boycott the above additional Examinations/Tests, now initiated.**

Hope your good offices will understand our sentiment and accede to our request and do the needful immediately.
