### **POSTPONEMENT OF TWO DAYS BANKING STRIKE ON 24<sup>TH</sup> – 25<sup>TH</sup> MARCH 2025**

With due regards, your attention is invited to our Joint Forum letter no – JF/14/2024-25, Dated – 03.03.2025, whereby it has been communicated that on the call of our central unit (AIRRBEA/NFRRBO/NFRRBE) the members of Chhattisgarh Rajya Gramin Bank Officer's Organization and Chhattisgarh Rajya Gramin Bank Employee Association had proposed to go on two days banking strike on 24<sup>th</sup>-25<sup>th</sup> March 2025.

Now it is worth to mention here that the conciliation meeting held by RLC (C) in the office of CLC, Delhi dated – 19.03.2025 and the conciliation meeting held by CLC (C) in the office of CLC, Delhi dated – 21.03.2025, The DFS, GOI and CLC have assured for the demands raised by the AIRRBEA & UFBU and appeal to reconsider the proposed call for the strike on 24<sup>th</sup>-25<sup>th</sup> March, 2025.

Since the Government has come forward with positive assurances on the raised demands, our central unit with reference to the decision taken by UFBU has decided to defer/postpone the proposed strike on 24<sup>th</sup> – 25<sup>th</sup> March 2025 for next day to be decided in future.
