## REQUEST FOR CLARIFICATION AND DIRECTIONS TO CHHATTISGARH RAJYA GRAMIN BANK (NON-AMALGAMATED RRB) TO COMPLETE PENDING PROMOTION PROCESSES.

Ref :- Our Joint Forum unit letter no – JF/29/2024-25, dated – 08.07.2025.

We, the undersigned union representatives, wish to bring to your esteemed notice on the ongoing concerns regarding the promotion process in Chhattisgarh Rajya Gramin Bank (non-amalgamated RRB). We acknowledge receipt of your email dated 10th July 2025, requesting clarification on the reference number and specific details of the letter issued by NABARD in relation to the pending promotion process.

As per the information we have received from our sources, the Chhattisgarh Rajya Gramin Bank is not publishing the promotion seats and results, even after completing the promotion process as per MITRA COMMITTEE, in accordance with the directive recorded in point no 10 of the NLPMU meeting minutes dated May 20, 2025 held under the chairmanship of Shri G. S. Rawat, DMD, NABARD at NABARD head office, Mumbai. The instruction quoted in minutes of that meeting is extracted below:

"DFS, GoI is framing the new HR policy for RRBs in consultation with Sponsor Banks and NABARD and is likely to be issued by end June 2025. The promotion and recruitment process may be placed on hold for till that time by all RRBs or till further instructions."

In view of the evolving circumstances and the importance of timely career advancement for employees, we request NABARD to kindly reconsider this position. We earnestly urge your good office to issue clear and specific directives to the Chhattisgarh Rajya Gramin Bank (non-amalgamated RRB) to resume and complete the pending promotion processes, adhering strictly to the existing rules and guidelines. Such a step will greatly boost employee morale and ensure transparency and fairness in the administrative procedures.

Thank you for your attention to this matter and we expect that necessary instructions will be issued from your office shortly in this regard. Looking forward to your response.
